The Domestic Animals Act 1994 requires any owner of a domestic animal (cat or dog) in Victoria to comply with various conditions, including those outlined below.

Registration

All domestic animals older than three months must be registered. Registrations are due in April each year. After the initial registration, a renewal invoice will be sent to your mailing address.

Fees

A fee exemption applies to dogs that are kept:

- for the purpose of assisting a visually impaired person
- by a Government authority

A reduced fee applies to a domestic animal that satisfies any of the following conditions:

- De-sexed
- Over 10 years of age
- Kept for working stock
- Has an obedience certificate issued by a Government approved organisation
- Part of a domestic animal business or an applicable organisation
- Is microchipped and was registered with Council prior to 11 April 2013

A maximum fee applies in circumstances other than those outlined above.

Current fees can be obtained from Council's Customer Service team or Council's website.

Pensioner concession

The following cardholders are eligible for a reduction on the applicable fee:

- Centrelink Pensioner Concession Card
- Department of Veterans Affairs Pensioner Concession Card
- Department of Veterans Affairs Repatriation Health Card specifying a War Widow TPI

Victorian Government Levy

Included in the registration fee is a Victorian Government Levy. It is primarily used to fund responsible pet ownership education programs.

Microchipping

Domestic animals must be microchipped before they can be registered.

Tags

Domestic animals are required to wear their registration tag when not at their registered premises. To order a replacement tag contact Council's Customer Service team.

Restricted breeds

The following breeds cannot be registered in Victoria:

- American Pit Bull Terrier (or Pit Bull Terrier)
- Dogo Argentino
- Fila Brasileiro
- Japanese Tosa
- Perro de Presa Canario (or Presa Canario)

Privacy notification

The personal information on this form is collected by Council for the enforcement and administration of animal control in accordance with Sections 10 and 18 of the Domestic Animals Act 1994. The personal information will be used by Council and its contractors for that primary purpose or directly related purposes and may be disclosed as required by law.
